If such a conflict does arise, I will declare that conflict in writing to the Board and refrain from voting on matters in which I have a conflict.
- 11. Keep confidential all information that is confidential.
- 12. Represent XYZ AIS in a positive and supportive manner at all times and in all places.
- 13. Exercise my authority as a Board Member only when working in concert with the full Board or when I have been delegated by it to do so.
